

CERTIFIED TRAINER

PURPOSE AND OBJECTIVES

The purpose of the Sertoma Certified Trainer (CT) Program is to develop Sertoma members by coordinated, targeted, quality training by Sertoma volunteers utilizing the curriculum and materials provided or approved by Sertoma. It is a leadership development activity established in 1987 to engage members who possess an interest and ability to train at all levels of the organization.

The CT Program provides qualified individuals advanced education and experience to develop them as trainers and presenters. These skills are used to support Sertoma's mission through education and support of our members.

Trainers report to the Sertoma Executive Director who coordinates matters of procedure and personnel with the input of the Sertoma Leadership Institute Advisory Committee (SLIAC) Chair.

TASKS AND DUTIES

- Conduct the training for new Clubs as assigned.
- Provide club counseling.
- Assist Sertoma officers and elected representatives in conducting meetings, inter-clubs, conferences, and conventions.
- Present Sertoma programs to clubs, districts, conferences or conventions when requested.
- Share selected lesson plans with SLIAC Chair for review.
- Avoid political activity in all Sertoma elections while training.

QUALIFICATIONS AND REQUIREMENTS

- Complete application on form provided by Sertoma.
- Be a Sertoma club member in good standing.
- Utilize the curriculum and materials provided or approved by Sertoma.
- Research Sertoma training resources available on the web site.
- Good working knowledge of Sertoma, at the club, district and national levels.
- Prior training experience desirable.
- Able to follow instructions and travel within the district and region.
- Completion of a training program recommended by SLIAC, or
 - Complete Regional Trainer course and conduct evaluated training
 - Have served adequately as a District Governor or higher office.
- Recommendation for certification by SLIAC and approval by the Executive Director.
- Completion of requirements for retention of CT status as recommended by SLIAC.

EVALUATION

Presentations are evaluated on a form approved by Sertoma and reviewed by SLIAC.
